To search by NAME, type in the FIRST and LAST NAME into the appropriate search boxes. Then, select the Name radio button and then press the ENTER key.

To search by Case Number, type in the CASE NUMBER, select the Case Number radio button and press the ENTER key.

Case Number is the default search.

Clicking the **Name Search Mini-List** check box will cause the name search results to display in the Mini-List below.

If the Name Search Mini-List check box is not clicked, the name search results will appear in the space towards the right of the AgaveWeb Search Controls. This is the default.
